# Assembly Bill 420 (Davis) Redistricting

#### ISSUE

With each redistricting cycle, the need arises to obtain an accurate population count for all districts which will elect state representatives. Currently, inmates incarcerated in California correctional facilities are counted wherever they are located, rather than based on their last known residence, for redistricting purposes. This practice has the effect of improperly inflating the population count in some districts, and carries with it the risk of affecting the redrawing of district lines.

#### **EXISTING LAW**

Elections Code 2025 provides that a person does not gain or lose a domicile by reason of his or her presence or absence from a place while kept in a state prison. This section controls the establishment of a person's domicile for voting purposes.

#### THIS BILL

AB 420 would change the method of the population count for redistricting purposes to make it consistent with Elections Code 2025. It would require the Department of Corrections and Rehabilitation to submit the to Commission on Redistricting, last known residence information for inmates incarcerated in California correctional facilities. Inmates whose last known residence is outside California would be excluded. While there will be no requirement that the Commission act on the information, there will be an expectation that the data provided will be factored into the redrawing of district lines.

#### **RECENT LEGISLATION**

There is no recent legislation on the issue of how inmates are counted for redistricting purposes.
